FOR ALL SOFTWARE COMPONENT PRODUCT(S)

By exercising your rights to install Peakboard Designer, you agree to be bound by the terms of this EULA, including the limitations and warranty disclaimers. If you do NOT agree to the terms of this EULA, you may not install nor use Peakboard Designer;

SOFTWARE PRODUCT LICENSE

1. GRANT OF LICENSE.

This is a license agreement, and NOT an agreement for sale. Peakboard GmbH retains ownership of the copy of Peakboard Designer in your possession, and all copies you may be licensed to make. Peakboard GmbH retains all rights not expressly granted to you in this LICENSE. Peakboard GmbH hereby grants to you, and you accept, a non-exclusive, non-transferable license to use and copy Peakboard Designer only as authorized below.

Provided that you have accepted these terms contained herein, this EULA grants you the following rights:

Installation and Use:

Pro License: You are granted a license for all developers (individuals) of your company and contractors that you authorized to use the software on your company's behalf to use Peakboard Designer including data connectivity for **XML, JSON, OData, JavaScript, Twitter, Facebook, Instagram, Excel, and Webpage** for one specific Peakboard-Box. At no time may Peakboard Designer be used by non-employed individuals of your organization for any purposes - nor may Peakboard Designer be distributed to any place outside your organization and nor may Peakboard Designer be used to transport data that is not owned by your organization or is publicly available.

Enterprise License: You are granted a license for all developers (individuals) of your company and contractors that you authorized to use the software on your company's behalf to use Peakboard Designer including data connectivity for **XML, JSON, OData, JavaScript, Twitter, Facebook, Instagram, Excel, Webpage as well as ERP-Connectivity for SAP and other available systems** for one specific Peakboard-Box. At no time may Peakboard Designer be used by non-employed individuals of your organization for any purposes - nor may Peakboard Designer be distributed to any place outside your organization and nor may Peakboard Designer be used to transport data that is not owned by your organization or is publicly available.

Trial License: This includes all rights and responsibilities associated with the Peakboard Designer License for a limited amount of time.

For All Licenses: In no case shall you rent, lease, lend, redistribute nor re-license Peakboard Designer or source code to a 3rd party individual or entity, except as outlined above. In no case shall you grant further redistribution rights for Peakboard Designer to the end-users of your solution.

2. DESCRIPTION OF OTHER RIGHTS AND LIMITATIONS.

Termination. Without prejudice to any other rights, Peakboard GmbH may terminate this EULA if you fail to comply with the terms and conditions of this EULA. In such event, you must destroy all copies of Peakboard Designer and all of its component parts, source code, associated documentation, and related materials.
